



Evolution of ton AB used per ANIMAL TYPE in Sanitel-Med with reference to sales data of 2021





Evolution of ton AB used and percentage of farms where it was used per ANIMAL TYPE in Sanitel-Med



Evolution of kg (fluoro)quinolones used and percentage of farms where it was used per ANIMAL TYPE in Sanitel-Med




Evolution of total kg (fluoro)quinolones used in Sanitel-Med with reference to sales data of 2021





Evolution of kg cephalosporines 3G/4G used and percentage of PIG farms where it was used in Sanitel-Med



Evolution of total kg colistin used in Sanitel-Med with reference to sales data of 2021






















BAROMETER SANITEL-MED: % OF FARMS IN EACH OF THE 3 COLOUR ZONES (1)

PIGS - Nursery piglets














Percentage of farms classified with each benchmark colour per ANIMAL CATEGORY


Total ton AB used per ANIMAL TYPE and BM_COLOR in Sanitel-Med
